TERMS & CONDITIONS

Candidate / Applicant must fulfill the following conditions:

1. Minimum 18 years education in the relevant field of study.
2. First class or CGPA 2.5 / 4.0 in BS/MA/M.Sc and CGPA 3.0/4.0 in M. Phil /MS.
3. Maximum of two 2nd divisions and no third division throughout academic career with 1st division in last degree earned.
4. The selected candidates have to secure admission in top 200 universities (For foreign and Split Scholarships) or/and HEC Recognized Universities in Pakistan (local and Split Scholarships). Those who have already enrolled and not availing any scholarship may also apply, but the award of Scholarship will commence after the selection by the Selection Board.
5. Maximum age limit is 35 years, relax able by 5 years in cases of Government / Semi-Government employees.
6. Have passed GRE subject test/GAT international conducted by NTS after August 2011.
7. Candidates who are already serving in Government / Semi-Government and autonomous bodies should apply through proper channel accompanied by N.O.C. from the employer.
8. Selected candidates have to appear before the University Selection Board.
9. There shall be two candidates against each scholarship to appear before the selection board for final selection.
10. After the award of the scholarship, the awardee will not change the course of study she is selected for (as specified in the letter of the award) without obtaining prior approval and permission from the Women University, Multan.
11. Scholarship will be awarded for the period of maximum four years. Scholar shall not extend the specified period of studies. Failing to comply the condition, The Women University, Multan reserves the right to recover entire expenditure from Scholar/Guarantor and shall not bear any binding for the job offer made otherwise in case of successful completion of the degree/course.
12. An awardee will not hold any other scholarship/ stipend during the period of her study under this scholarship.
13. The scholar shall not undertake any other employment whether paid or otherwise during her course of studies.
14. The scholar shall regularly submit the six monthly progress reports on her assigned Program through her supervisor to The Women University, Multan and a final comprehensive report immediately on completion of the study/research.
15. An awardee shall sign an agreement in the form of surety bond with the Women University, Multan on non-judicial(stamp) paper clearly mentioning that she will be liable to serve the Women University, Multan after the completion of the study for a period of 5 years, in case she violates or fails to fulfill the terms and conditions laid down in the bond for studies under this scholarship program, the Women University, Multan reserves the right to recover the entire expenditure spent on her studies and in addition to this the scholar/awardee will be called upon to pay to the Women University, Multan the penalty as prescribed and assessed by the authorities.
16. The scholar shall refrain from engaging herself in any activity incompatible with her program of studies.
17. A personal guarantee of a guarantor on stamp paper, ensuring the recovery in case of default, would need to be furnished.
18. The decision of the Women University, Multan's committee concerning the selection of a candidate will be final and binding.
19. Authorities reserve the right to reject any application deems inappropriate or otherwise deficient.
20. Incomplete application forms will not be processed.

8. Subject in terminal degree and its Specialization are required to be mentioned at the top of the application.
